MSc: Advanced Clinical Practice in Ocular Health



The Aston school of Optometry are offering an exciting new Masters programme for allied health professionals working in Ophthalmology to progress as Advanced Clinical Practitioners. The programme is based on the Ophthalmic Common Clinical Competency Framework (OCCCF) and is open to Optometrists, Orthoptists and Nurses working within the field

of Ophthalmology. Teaching and learning will combine the 4 OCCCF clinical areas of: Medical retina, Glaucoma, Cataracts and Acute and Emergency Eye Care, with the Advanced Clinical Practice pillars of Leadership and Management, Education and Research. Additional topics will also include ocular anatomy, medical skills, examination techniques (foundation and advanced), nutrition and myopia. Optometrists can gain independent prescribing status along with College of Optometrists accredited professional certification in the areas of Medical Retina and Glaucoma as part of the course. Shorter Post-graduate Certificate and Diploma routes also available, as well as the opportunity to undertake standalone modules from the programme. We will be holding a webinar for Ocular Health, Monday 21st March, 11.30am—12.30pm, further details to be sent shortly. ACP Governance Project

This HEE funded project looked to produce overarching cross sector ACP governance and assurance guidance. Alongside support for systems, organisations, people and advanced practitioners. The main project aim was to create a reusable object that will provide guidance for organisations looking to implement advanced practice services or further support current advanced practice teams. An ACP governance and assurance maturity matrix is being produced alongside employers and other key stakeholders to further support the governance and assurance of advanced practice within organisations, the document will link to resources ensuring best practice is being shared.

Midwifery Advanced Practice

The regional faculty leads across the 7 NHS regions are working with HEE's National Maternity Programme on developing more advanced practitioners in midwifery. We are hoping to recruit up to 40 midwives in 22-23 who will be able to undertake MSc Advanced Clinical Practice programmes at prospective partner universities, where we plan to offer clinical competencies related to midwifery

advanced practice. In the Midlands region we will be liaising with Directors / Heads of Midwifery to scope demand for midwives to undertake advanced clinical practice training, with requirements for trainee ACP posts, suitable supervisory arrangements, and workforce development plans for midwifery ACP posts within their respective services on completion of training. Our Advanced Practice Training Programme Director for Midwifery, Liz Bennett Hayes, will be focusing on this area of advanced practice developments as part of her role.

ePortfolio (supported) Route Update

The first round of applications for the ePortfolio (supported) Route closed at the end of January. The Centre for Advancing Practice and regional faculties have been reviewing the received applications. Those will now be passed over to the advanced practice academic teams at universities across the country who are participating in the ePortfolio (supported) Route. The universities will conduct an initial Learning Needs Analysis (LNA) with applicants to assess their suitability for progression onto completing the subsequent ePortfolio to demonstrate mapping again suit the HEE



(2017) Multi-professional framework for advanced clinical practice in England. The Centre for Advancing Practice and regional faculties will be liaising with the partner universities to brief them on the requirements for completing the initial LNA and supporting and assessing the subsequent ePortfolio (for applicants who can progress to that stage). Successful completion of the ePortfolio (supported) Route will link to a 'digital badge' (digital badges are validated/verified indicators of accomplishment, skill, or quality earned through learning).

Data Collection of the ACP Trainee Workforce

The Midlands regional Faculty for Advancing Practice is working with 35.64,50656.8,0,0,0,0,30 101 34 the other regional faculties to develop information systems for colleting data about our ACP trainee workforce. For the purposes of workforce modelling, we need to have more accurate data about trainee workforce such as registrant background, speciality area, and route of advanced practice preparation. The South West Faculty for Advancing Practice has led on the development of a data collection tool for monitoring purposes, which will be trialling in the Midlands region over the next few months to ensure more effective monitoring of our ACP trainees.

Health Education England Advanced Practice Supervision Pliot – Plioting the 'Roadmap Supervision **Course** with

Advanced Practice Supervisors Across the Midlands

There is a need to develop a standard for quality supervision to support advanced practice trainees in all healthcare settings across the Midlands region. A standard for supervision has been set in primary care with the Additional Roles Reimbursement Scheme (ARRS for First Contact Practitioners (FCP) and the 'Roadmap Supervision' course for their supervisors. The Roadmap Supervision Course covers broad-based principles of supervision and how to



undertake Workplace Based Assessments (WPBA) which is relevant to all clinical settings.

Extension of the Roadmap Supervision course to supervisors of advanced practitioner trainees, such as senior, experienced advanced practitioners would support the development of an agreed standard of advanced practice supervisors across all settings, known to the regional Faculty for Advancing Practice.

Over the next few months, The Faculty's Programme Lead for Advanced Practice in Primary Care, Julia Taylor, will be leading on a pilot project to deliver the Roadmap Supervision Course to some cohorts of experienced, qualified advanced practitioners from a range of clinical settings across the Midlands (including acute trusts, community, mental health, primary care, and out-of-hours services).

The current Roadmap Supervision course is 2-day course which can be delivered either online or in-person, normally by two trainers. The course focuses on the importance of quality supervision as a facilitative and supportive process. Looking ahead, if the pilot is successful, the Faculty will work with colleagues to identify and train up some regional trainers to deliver the course on a wider ongoing basis.

To be successful this pilot project will require collaborative working with our Regional Advancing Practice Supervision and Assessment Leads, our Advanced Practice Training Programme Directors, the Midlands Primary Care School, the Centre for Advancing Practice, our university partners delivering advanced practice education, and also engagement with a variety of employers/providers/settings who employ advanced practitioners. The Midlands regional Faculty will also be working in collaboration with the London regional Faculty for Advancing Practice who will be correspondingly piloting this project in their region.
